Why is the date on my certificate different than the date of the audit?

At the conclusion of your audit, the lead auditor made a recommendation for certification. One or more members of TÜV SÜD's Certification Committee have independently reviewed this recommendation. Your management system is considered certified on the date this committee approved the recommendation.

When are my audits due?

Audits are based on the date of the original certification audit. We must conduct the first surveillance within one year of the initial decision date to issue you the certificate. On an ongoing basis we need to conduct at least one surveillance audit each calendar year. We are obligated to suspend certificates if we are unable to conduct surveillance audits by the due date. Please refer to your audit agreement for details.

We received a certificate for the applicable standard(s). What do we do with our previous certificate(s)?

Upon receipt of your new certificate(s), please return or destroy all previous copies.

Why is my certificate valid for less than three (3) years?

There are several possible reasons. You are likely aware that many standards are currently in a transition period. All certificates issued to the previous revisions must have an expiration no later than 3 years from the new revision issue date. Below are the maximum expiration dates for certificates containing the below referenced standards.
